District Points

I bring you greetings from Provincial Command and District G Commander;

Since March 15, lots has happened, through PAC and PEC the General By Laws have been amended giving the Branch executive the authority to make decisions on behalf of the Branch;

The Opening of Patios over the summer months was successful for those Branches that took the opportunity:

Most Branches have since re-opened, adhering to the COVID 19 Protocols, as laid down by your Local Public Health Unit.

District G still has Branches that have not opened yet, some due to the seriousness of the Pandemic, some for the lack of Volunteers and some may never re-open due to finances.

There were funds available for Branches, the first instalment was a 1k allotment issued by Dominion Command, and Provincial Command reimbursed all Branches their 2019 per capita, this appeared to suffice in the beginning as no-one knew how long the pandemic was going to last:

Then came the funds from Dominion Command, this was handled a little differently, as these funds were distributed to the Branches most in need. All Branches were asked to send in the questionnaire and fill out the form if funds were required at the moment;

All PAC and PEC meeting were via Zoom as this proved to be great tool.

By Laws were amended to give the Dominion President, Provincial President, District and Zone Commanders a 3 year term as these positions are governed by the General By Laws. This means that the subsequent terms will also be a 3 year term. This means that Dominion will return to a normal rotation in 2024 and Provincial in 2025.

Since Branch regulations are voted on by the membership these cannot be amended, and this throws a wrench into the system. Since there does not appear to be an end in sight for this Pandemic, Dominion Command has authorized Provincial Command to suspend all Branch Elections until the spring of 2021...... If your Branch has a 2 year term then we will guide you through the process.

Poppy campaign, this year will not be the same as last year, let's get on with the new normal, find ways of getting the support out there. All Zone Commanders were given the instructions.

Remembrance Day, again the New Normal will dictate, All Zone Commanders were given the instructions.

October 3rd, VSO/Poppy Seminar in Smiths Falls, Only Zone VSO's, Zone Poppy Chairs, Zone and Deputy Commanders are invited, due to COVID Protocols. They in turn will give the presentation to the Branches in their Zone.

District Council will be held on Oct 18th in Brockville;

Branch Annual Inspection will be conducted as usual and the reports are to be sent up the chain of command in a timely fashion. The new up-to-date inspection forms are on the Provincial web site under Forms and Manuals, Leadership and Development. I would suggest that branch presidents download the form and review it as there are changes from previous years.

Poppy reporting, the same applies, Poppy reporting year is from Oct 1st 10 Sept 30th, If all Branch Ledgers are properly maintained the Poppy reporting is a breeze.... Branch Poppy Annual Inspections shall be completed **NLT Dec 15**.

Poppy Special Use forms must be used in accordance to the Poppy Manual and a copy of the latest bank statement shall be submitted at the time of the Inspection;
